A look at 2014...by the numbers Generous giving continues steady climb for fourth straight year

- Total donations to the Foundation in fiscal year 2014, which ended September 30, 2014: **\$366,482**. This represents a 3% increase in donations over the previous fiscal year and marks the largest year for donations in the Foundation's 25-year history!
- The Foundation acquired private grant dollars on behalf of Stanly Regional totaling \$160,069 last year. This included a \$69,181 grant from the Cannon Trust, a \$9,000 grant from the National Children's Alliance, and an \$81,888 grant from the NC Governor's Crime Commission – all for operating costs at the Butterfly House.
- Income from interest & dividends on the Foundation investment account for the 2014 fiscal year totaled \$197,282.
- Carolinas Healthcare System (CHS) donated \$2 million in cash to the Foundation last year when the hospital merger took place. In addition, CHS donated three pieces of property which the Foundation subsequently sold for a grand total of \$452,230 (of the properties sold, only one closed before our fiscal year ended, bringing in income of \$324,350).
- Total income for the Foundation including donations, grants & investment income was \$3,048,183.

The Foundation Board of Directors and staff are ever-grateful to our donors who continued to make health care a priority in their charitable giving in 2014. We look forward to partnering with you to continue our mission of raising funds to improve patient care and the health of our community in the coming year!


