Cabarrus College researched educational requirements for the following states and territories, and per federal requirements, has determined whether or not its program curricula meet educational requirements for licensure/certification. In some instances, such as Idaho and Virginia, the College was unable to make a determination at this time although graduates can sit for NC licensure and practice in these states by virtue of a Compact State License. Please note that each state likely has additional requirements for becoming licensed or certified.
