Occupational Therapy and Occupational Therapy Assistant

Cabarrus College clinical programs embrace best practices in healthcare education and prepare students for professional licensure, certification, and practice. All educational programs that are accredited by the *American Occupational Therapy Association* and the *Accreditation Council for Occupational Therapy Education* are required to prepare graduates to be a generalist and to pass the certification examination.

The National Board for Certification in Occupational Therapy maintains a [list of each state agency regulating certification and licensure](#), along with contact information. Currently educational requirements to apply for licensure to practice and to sit for potential licensure examinations vary from one state to the next. AOTA is creating an interstate professional licensing compact for occupational therapy to address licensure portability. The Occupational Therapy Licensure Compact legislation must be passed into law in each state where it will apply. The goal for this multi-year initiative is for state participation to begin in 2024.

Cabarrus College researched educational requirements for the following states and territories, and per federal requirements, has determined whether or not its program curricula meet educational requirements for licensure/certification. In some instances, the College was unable to make a determination at this time. Please note that each state likely has additional requirements for becoming licensed or certified.

Cabarrus College strongly encourages prospective and enrolled students to contact the licensing board or regulatory agency in the state/territory in which they wish to practice for additional information and to confirm whether successful completion of our program meets state credentialing requirements.
