

Purpose

The purpose of this Back to Campus Plan is to facilitate a procedure for teammates and students to return to teaching, learning, and service to one another at Cabarrus College. This plan utilizes the Opening Up America guidelines provided by the Federal Government and Center for Disease Control.

COVID-Safe Standards

- a. Maintain a **COVID-Safe educational environment** by requiring screening, universal masking, and social distancing of all students and teammates when returning to campus.
- b. **Rapid testing and results** through Atrium Health for students and teammates who meet COVID testing criteria.
- c. **Dedicated facility** exclusively for non-COVID students and teammates.
- d. **Virtual, online campus** for COVID-positive students and teammates, those who are high risk, or have dependents who are high risk.
- e. Lead other institutions with **delivery of exemplary healthcare education**, even during a global pandemic.



Safety First – Students and Teammates

Screening – Conducted in our campus building and at Atrium Health Cabarrus Hospital.

Testing – Performed through Teammate Health for employees. Available for students and visitors through Atrium Health by first calling (704) 468-8888.

Contact Tracing – After being diagnosed as COVID positive, residents of Cabarrus County will be traced by the Cabarrus Health Alliance. Residents of other counties will be traced through the county public health authority in which they reside.

Screening

All entrants to the campus building will be subject to screening. Once screened, individuals will be provided a colored wristband or sticker to indicate they have passed the screening protocol. Entrants should plan on arriving **30-minutes prior to your anticipated start time** to complete the screening process.

Locations

1. College Building - Screening for COVID-19 will occur in the college building within certain time frames. During Phase 1 screening will be provided on campus Monday through Friday in between 7:30 am and 8:15 am and 30-minutes prior to scheduled lab sessions.
2. Atrium Health Cabarrus Hospital – Screening is available 24 -hours per day at the hospital for students, teammates, and visitors who wish to enter the college when screening is not being provided at our campus building. Individuals should proceed to the Teammate Entrance (teal blue awning entrance near the Surgery Center) to be screened and to receive a screening sticker or wristband.

Screening Protocol

1. Questions – Entrants will be asked to respond truthfully to a series of questions asked by a Screener:
 - a. Do you have any of the following symptoms?
 - i. Fever, chills, or sweating
 - ii. Shortness of breath or difficulty breathing
 - iii. New or worsening cough
 - iv. Sore throat
 - v. Muscle pain or body aches
 - vi. New loss of taste or smell
 - vii. Nausea, vomiting, or diarrhea
 - viii. New (less than two weeks) significant, unexplained headache
 - b. In the last 2 weeks, did you do any of the following?
 - i. Have close contact with someone who has COVID-19
 - ii. Travel internationally
 - iii. Live in or visit a place where COVID-19 is widespread
2. Temperature Check – Entrants will have their temperature checked with a touchless thermometer.

Screening Verification

Entrants will need to show their color-coded wristband or sticker to the front desk attendant to enter the building. Individuals who do not have the appropriate wristband or sticker will be denied access and will need to go to the hospital to be screened.

Masking

All entrants will be required to wear a mask. One cloth mask will be provided to each student and teammate. It is the responsibility of students and teammates to launder the mask on a routine basis.

Social Distancing

Strict social distancing practices will be in effect. For teaching and learning, the college will use a combination of online learning, simulations, and limited on-campus activities. **Unless approved otherwise, students and faculty should only come to campus for authorized labs, lectures, and scheduled appointments.**

Teammates will work from home, conduct virtual meetings, and come to work in shifts where possible. **Faculty and staff should only come to campus to conduct college business when authorized by the Provost or their appropriate Dean.**

Classroom and lab capacities will be reduced to ensure social distancing and traffic flow throughout the building will be controlled to minimize social contact. Please see content on room capacities and traffic flow below.

Traffic Flow

1. Traffic flow will be indicated with the use of signage, with tape of floor or both.
2. Going upstairs – Elevator access the 2nd & 3rd floors.
3. Exiting the Building – Back (North) stairwell to exit the building. Individuals with mobility issues may use elevator.
4. Those who use the elevators (2-persons per car) must wait in line with 6 ft spacing.
5. Hallway traffic will be managed using a one-way traffic pattern.
