Certification Disclosure
Computerized Tomography**

Carolin College clinical programs embrace best practices in healthcare education and prepare students for professional licensure, certification, and practice. Educational requirements to sit for credentialing examinations and to practice vary from one state to the next.

Carolin College researched educational requirements for the following states and territories, and per federal requirements, has determined whether or not its program curricula meet educational requirements for licensure/certification. Please note that each state likely has additional requirements for becoming licensed or certified.

Carolin College strongly encourages prospective and enrolled students to contact the licensing board or regulatory agency in the state/territory in which they wish to practice for additional information and to confirm whether successful completion of our program meets state credentialing requirements. Students who complete the Computed Tomography coursework meet all requirements to sit for the ARRT certification exam and to apply for initial licensure in all states. Some states require additional state sponsored training as part of the initial license application. Those requirements are the sole responsibility of the licensing state.
